

## LAKESIDE JOONDALUP SHOPPING CITY – ROCKY HORROR SHOW - GIFT WITH PURCHASE (SPEND & RECEIVE)

---

### Terms and Conditions

1. The Promoter is Lendlease Property Management (Australia) Pty Limited ABN 61 002 894 153 of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is 08 9404 9011.
2. Only residents of Western Australia aged 18 years or older (Participant) are eligible for the promotion.
3. The following person(s) are ineligible to enter the Promotion:
  - (a) employees of:
    - (i) any retailer within Lakeside Joondalup Shopping City
    - (ii) the Promoter; and
    - (iii) the Promoter's related bodies corporate (as that expression is defined in the *Corporations Act 2001* (Cth), and associated agencies, companies, and contractors; or
  - (b) members of the Immediate Families of the employees

**Immediate family** means any of: a spouse or domestic partner, ex-spouse or ex-domestic partner, de-facto spouse or ex-de-facto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.
2. The Promotion commences and Free Gifts are available between **9am to 3pm on Saturday 29 July or until 100 Rocky Horror Show tickets have been exhausted (Promotion Period) and 11am to 4pm on Sunday 30 July or until 100 Rocky Horror Show tickets (Promotion Period)**, whichever is earlier. All times are in AWST.
3. There will be a registry of all Free Gifts claimed at the dedicated Rocky Horror Show kiosk located on Level 1 in the Myer Mall, outside Shingle Inn at Lakeside Joondalup Shopping City. There are a total of 200 Free Gifts available. Once the allocated number of Free Gifts have been claimed on Saturday 29 July and Sunday 30 July (the Promotion Period), the promotion will cease. Any leftover Free Gifts from the that day's allocation will be added to the following day's allocation.

The 'Free Gift' is 2x A Reserve tickets per person to the Rocky Horror Show at Crown Theatre Perth on Tuesday 15 August at 7:30pm valued at \$120 AUD each or 2x B Reserve tickets per person to the Rocky Horror Show at Crown Theater Perth on Wednesday 16 August at 7:30pm, valued at \$160 AUD each. Customers cannot request a show date.
6. For a customer to receive 2x tickets to the Rocky Horror Show at Crown Theatre Perth ("Free Gift") from the **Lakeside Joondalup Shopping City Rocky Horror show kiosk, located on Level 1 in the Myer Mall, outside Shingle Inn**, they are required to spend a minimum of \$150 at participating retailers and present the Promoter with a paper copy of the receipt/s evidencing a total minimum spend of \$150 at Participating Retailers (refer to clause 10e) within Lakeside Joondalup Shopping City. A limit of 2x tickets to the Rocky Horror Show at Crown Theatre Perth "Free Gifts" per customer per day (Promotion Period) is applicable.
