

Competition (game of chance) terms and conditions including the Privacy Statement

Terms and Conditions

1. The Promoter is Lendlease Property Management (Australia) Pty Limited ABN 61 002 894 153 of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is 08 9404 9013.
2. Participants under 18 years of age must obtain the prior permission of a parent or guardian over the age of 18 years to enter the Competition.
3. The following person(s) are ineligible to enter the Competition:
 - (a) employees of:
 - (i) the Promoter; and
 - (ii) the Promoter's related bodies corporate (as that expression is defined in the *Corporations Act 2001* (Cth), and associated agencies, companies and contractors; or
 - (b) members of the Immediate Families of the employees referred to at paragraph 1(a).
Immediate family means any of: a spouse or domestic partner, ex-spouse or ex-domestic partner, de-facto spouse or ex-de-facto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.
4. The Promotion Period commences at 9am AWST on Friday 21 June 2024 and closes at 5pm AWST on Sunday 23 June 2024 (**Competition Period**), with The Vault open and free gifts available during the following dates and times:
Friday 21 June 2024 9am – 5pm, Saturday 22 June 2024 9am – 5pm and Sunday 23 June 2024 11am – 5pm (**Competition Period**). A total of 8x winners will be drawn on Monday 24 June 2024 by 10am AWST, the first winner drawn will be contacted to select a 'free gift' of their choice, this 'free gift' will then be removed from the prize pool for each following prize draw. In order of prize draw, each winner can select their own prize from the available prize remaining prize pool. The 8th (eighth) and final winner will not have a choice of prize as there will only be 1 (one) remaining prize in the pool. Each winner will be contacted on Monday 24 June by 4pm AWST. If a winner is unable to be contacted by phone for their prize confirmation, they will have 30 minutes to return the phone call before the next winner is contacted and their position in the prize draw is demoted. A winners position in the prize draw may be demoted as many times as required until the winner can be contacted. The Promoter may extend the Competition Period at its sole discretion (**Extended Competition Period**). Details of any Extended Competition Period will be posted on the Lakeside Joondalup Shopping City website. References in these terms and conditions to the Competition Period include any Extended Competition Period, where applicable.
5. There will be 8 'free gifts' available in total from The Vault. The 'free gifts' include 1x Gucci Marmont Bag (\$2,025.00), 1x Charlotte Tilbury Supermodel Kit (\$340.00), 1x Sunday Riley Skincare Pack (\$154.00), 1x Estee Lauder Mini Lip Care Duo (\$75.00), NuFace Mini Starter Kit (\$420.00), 1x Dyson Airwrap Complete Long Multi-Styler (\$849.00), 1x \$1,000 Lakeside Joondalup Gift Card, 1x \$2,000 Flight Centre Voucher, 1x New Balance 9060 (\$230.00), 1x Adidas Originals Samba OG (\$179.99), or 1x Prada 17WS Sunglasses (\$624.00). For the 1x New Balance 9060 (\$230.00) and 1x Adidas Originals Samba OG prizes, the winner will need to provide their shoe size to see if these 'free gifts' can be ordered in their size. All prizes are dependent on product availability in the relevant styles or sizes and if unavailable, the customer will be offered a Lakeside Joondalup Shopping City Gift Card to the value of the RRP of the prize that has been won. In total, there will be 8x 'free gifts' to be claimed at The Vault with a total prize pool of **\$7,896.99 AUD**. Not all customers who participate in The Vault will receive a Free Gift.
6. To enter The Vault, the Participant must present the Promoter with a copy of their printed receipt evidencing a total spend of \$90 or more across multiple transactions from any participating retailer (refer to clause 16) within Lakeside Joondalup Shopping City during the Competition Period. The customer will be provided with an entry form by The Vault staff,

including prompts to complete their name and contact details. The entry form will then be entered into a barrel located at The Vault. Not all participants are eligible for a prize, only participants who are drawn at random on Monday 24 June 2024.

7. To redeem any of the 'free gifts', the winner must be over 18 years of age to redeem the prize, or if under the age of 18 years, a parent or guardian must accompany the winner and sign for collection of the 'free gifts'. To participate in The Vault, the receipt presented must be dated during the promotion period referred to in clause 4 of these terms and conditions and be from any **participating** permanent retailer within Lakeside Joondalup Shopping City referred to in clause 16 of these terms and conditions. To enter, the minimum spend must have occurred during the promotional period referred to at condition 4 of these terms and conditions. Receipts outside of these dates will not be accepted.
12. Bill payments such as the payment of credit card bills, bank transactions, digital receipts bank fees and charges and service bills (such as gas, electricity, rates and phone bills) are not accepted as part of this Promotion. Receipt from the purchase of gift vouchers, lottery products or tobacco products are not accepted.
13. For the Participant to be eligible to compete in the Promotion, the Participant must enter the Promotion:
 - (a) within the Promotion Period;
 - (b) in the strict manner specified at The Vault for the Promotion;
 - (c) by the method specified in these terms and conditions; and
 - (d) relying on a receipt dated within the Promotion Period from participating retailers.
14. To meet the minimum spend requirement of \$90, receipts can be combined. Each entry requires an individual transaction of \$90 or more at participating retailers at Lakeside Joondalup Shopping City.
15. Participating retailers for this Competition include all permanent retailers within Lakeside Joondalup Shopping City, excluding Coles, Woolworths, Aldi and pop-up temporary retailers.
16. The Free Gifts are not redeemable for cash.
17. The Free Gifts are personal to the winner. They cannot be transferred, exchanged or otherwise dealt with.
18. The Promoter assumes no responsibility for lost, misplaced, destroyed or stolen Free Gifts once they are claimed.
19. The Promoter reserves the right to refuse this offer to any person and reserves the right to request winners to provide proof of age and identity and eligibility to participate in the Promotion. In the event that a winner cannot provide suitable proof, the winner will forfeit the Free Gift and no substitute will be offered.
20. Nothing in these terms and conditions is intended to exclude, restrict or modify rights which the Participant may have under any law (including the Australian Consumer Law) which may not be excluded, restricted or modified by agreement ('Your Consumer Rights'). Subject to Your Consumer Rights, the Promoter is not liable for any loss or damage however caused (including by negligence), suffered or incurred in connection with the Promotion or any gift. Any condition or warranty which would be implied by law into these terms and conditions is excluded.

21. As a condition of accepting a Free Gift, the winner (or the winner's parent or guardian), and any other person(s) sharing the Free Gift with the winner, may be required to sign legal documentation as and in the form required by the Promoter including but not limited to a further agreement to exclude liability of the Promoter for certain loss, damage or injury arising from the use or participation in a gift to the extent the Free Gift is or includes a recreational service or activity.
22. All entries become the property of the Promoter. All entries will be entered into a database and the entrants' names and addresses may be used as detailed in the privacy collection statement which accompanies these terms and conditions.
23. The Promoter may cancel the Promotion and not award the Free Gift(s) and/ or Major Prize(s) where circumstances beyond the Promoter's reasonable control prevent the Promoter from providing the Free Gift(s). Should the Promoter cancel the Promotion the Promoter will:
 - (a) advertise that the Promotion has been cancelled by placing a notice on the Promotion's website at on www.lakesidejoondalup.com.au
 - (b) promptly destroy all entries received; and
 - (c) not use the personal information that any Participant has provided on the redemption form.
24. All gifts are accepted entirely at the risk of the winner, and the Promoter excludes all warranties in connection with any gift to the extent permitted by law. The Promoter reserves the right to substitute any gift with a gift and/or prize of equal or greater value (including where the gift is unavailable) for whatever reason, subject to approval of the gaming authorities in each State and Territory where required.
